Terms & Conditions

1. Separate and distinct rates are to be tendered for each category of Waste per kgs.
2. Price shall be for delivery Ex. our Mills at Vazhani, Wadakkanchery, Thrissure
3. GST / taxes and duties of the State/Central Government and local bodies shall be extra to buyer's account at rates ruling at the time of invoicing/dispatch.
4. The tender shall be sent only by Registered Post super scribing the Envelop " "TENDER FOR SALE OF WASTE " accompanied by a

security deposit/EMD of Rs **20,000/- (Twenty Thousand only)** for **Waste & Scrap** in the form of crossed Demand Draft/Cash drawn in favor of The Managing Director, The Trichur Co-operative Spinning Mills Ltd and payable at Wadakkanchery. In the absence of the deposit, tender will not be considered.

5. The bidders should remit an amount of **Rs. 250.00 (Two hundred and fifty only)** as tender form cost while submitting the Tender. Tender form is available in our website: **www.tcsmltd.co.in** or can be collected from the Mill after remitting the tender form cost. Tender without EMD & Tender form cost will be summarily rejected.
6. The tender along with the EMD & Tender form cost should reach the Mills on or before **24 Aug 2019, 10.30 am**
7. An **auction** will be held at **11.00 am on 24 Aug 2019** before **opening the tender**. After opening the tender the same auctioned rate and bid rate will compare and the highest rate will be considered.
8. It should be the duty of the buyer to take delivery of the allotted Waste from Mills and arrange despatch at his/their own cost.
9. Accumulated Waste shall be taken delivery of within **07 days (SEVEN DAYS)** of auction or sale order.
10. The Mills reserves the right to forfeit amount already paid if any, and to dispose of the Waste & Scrap by private treaty or public auction without giving any further notice to the allottee failing payment in full and lifting the Waste within 07 days of the date of receipt of the acceptance letter from the Mills. The short fall, if any in realization shall be recovered from the allottee at his/their own cost. The allottee shall have no right of whatsoever nature over realization in excess of the value of the allotted waste at the accepted rates if any.
11. The Waste may be inspected on any working day between **10 AM to 4 PM** in the Mills and no claim for reduction in price or allowance of any description whatsoever will be entertained in regard to the quality of the waste once they are allotted.

12. Security deposit of successful tenderers will be retained by the Mills as security for due performance of the contract. This sum shall be refunded on completion of the contract and payment of dues in full.
13. Security deposit of unsuccessful tenderers will be refunded by means of crossed cheque/cash.
14. The security deposit is liable to be forfeited for breach of any or all of the conditions herein.
15. The Mills reserves the right to appropriate for its own use whatever quantity of and quality of waste required for the Mills.
16. The Mill reserves the right to reject any or all the tenders without assigning any reasons therefore.
17. Each tender will be provided with 2 copies of the tender Schedule, out of which one copy should be returned by quoting rate and accepting the terms and conditions, and signing at the place provided below with seal.
18. Dispute arising out of this tender, will be dealt with only in a court with Wadakkanchery Jurisdiction.
